**Notice Inviting Expression of Interest (EOI) under DDU-GKY 2.0**

Tripura Rural Livelihood Mission (TRLM) invites EOI under Deen Dayal Upadhyaya Grameen Kaushalya Yojana 2.0 (DDU-GKY 2.0) for the state of Tripura from the eligible Project Implementing Agencies (PIAs) having valid Permanent Registration Number (PRN) obtained from the Ministry of Rural Development (MoRD), Govt. of India for placement linked skill development training of 650 rural poor youths in the financial year 2025-26. Interested PIAs having valid PRN, including all those organisations currently working as PIAs under DDU-GKY 1.0 are also required to obtain a fresh PRN for participation under DDUGKY 2.0. and may apply in the online portal of MoRD i.e. <https://kaushal.rural.gov.in> along with the non-refundable fees of Rs.25,000/- made through NEFT/RTGS for Initial Screening in favour of NIRDPR DDUGKY Savings Bank Account, No: - 62431332037, IFSC Code: - UTIB0004458. Eligible agencies will deposit non-refundable amount of Rs.1,25,000/- plus applicable GST for Qualitative Appraisal. Applicant PIA should read the DDU-GKY 2.0 program guidelines and Standard Operating procedures (SOPs) of MoRD carefully before applying.

Under DDU-GKY 2.0 agencies are encouraged to train and place candidates according to the skill gap existing in different sectors preferably in sectors matching the aspirations of the beneficiary youth of the state and with a potential for retention on the job such as IT- ITES, Agriculture, Rubber, Apparel Made-Ups & Home Furnishing, Logistic, Tourism & Hospitality, Electronics, Construction, Automotive, Beauty and Wellness, Food processing, Handicraft, Hydrocarbon, Green Jobs & Domestic Worker. TRLM also encourages employers/industries who can commit captive placements and having valid PRN to apply under this EOI. The training (residential) is to be completed by 31st December 2025 and placement by 31st March 2026. The State's Project Approval Committee (SPAC) is the final authority for sanctioning of the project based on requirement of the state and merit of the proposal in line with DDU-GKY 2.0 program guidelines and SOPs. The decision of SPAC will be final and binding on all the agencies.

1. **In order to be eligible to apply for a project under DDU-GKY 2.0, an entity should be: -**
  - a. Registered under Indian Trust Acts or any State Society Registration Act or any State Cooperative Societies or Multi-State Co-operative Acts or the Companies Act 2013 or the Limited Liability Partnerships Act 2008, or SHGs and its federations namely Cluster Level Federation/Block Level Federations;
  - b. A Government or semi-government organization at the State and National Level
  - c. NGOs must be registered with NITI Aayog's Darpan Portal
  - d. Be more than three years old at the time of application except Start-ups.

2. **Category of PIAs:** There shall be four categories of PIA under DDU-GKY 2.0, namely:
  - a. Captive Employers
  - b. Existing PIAs having experience of greater than 50% placement with DDU-GKY
  - c. Skilling Agencies who do not have any DDU-GKY experience
  - d. Start-ups for Skilling recognized by Dept of Industrial Policy & Promotion, Ministry of Commerce & Industry, Govt of India
3. **The following shall not be eligible for applying in DDU-GKY 2.0:**
  - a. Existing PIAs who got DDU-GKY Projects sanctioned and have recovery proceedings going on.
  - b. Existing PIAs who were unable to place 50% of Trained candidates under DDU-GKY
  - c. Skilling agencies having officials at key managerial personnel as per accounting standard 18, who were earlier associated with defaulting PIAs against whom recovery proceedings were initiated due to default.
  - d. Sister concern/subsidiary of any organisation against whom default action for recovery of funds initiated.
  - e. Skilling Agencies having Directors involved in agencies that defaulted earlier with DDU-GKY. A provision shall be built into the system for validating the DIN of directors of the applicant organisation through MCA database.
  - f. Skilling Agencies blacklisted by Government.
  - g. No consortium shall be allowed.
